1) Proposal submitted by Adarsh higher Secondary School, Himmatnagar, Sabarkantha along with relevant documents.

2) Provisional order passed by Fee Regulatory Committee for academic year 2017-18.

FINAL ORDER DATED: 13/8/2018

- Adarsh higher Secondary School, Himmatnagar, Sabarkantha has 1. submitted its proposal with relevant documents. After considering the said proposal along with the documents produced by the School Management, the committee has determined the provisional fees for the academic year 2017-18.
- As per the order passed by the Hon'ble Supreme Court of India on 1/2/2018 in SLP (C -NO. 314/2018) a detailed procedure for determination 2. of fees for self financed schools was prescribed. Pursuant to the said order of the Hon'ble Supreme Court and after considering the proposal submitted by the school management the committee has passed order determining the provisional fees on 29/05/2018. On receipt of the said order, the school management is supposed to file its objection against determination of provisional fees within one week from the date of receipt of the said order. More than three months have passed and yet the school management has not filled any objections. The committee is





therefore of the view that the provisional fees determined by the committee are acceptable to the school management and the school has been charging its fees accordingly.

- 3. Even otherwise, while passing the provisional order, the committee has directed the school management to place the provisional order on its notice board or website and if any objection is raised by the parents, the same shall be brought to the notice of this committee. Neither the school management has informed the committee about any objection from the parents nor any objection is directly received by the committee from the parents, against the determination of provisional fees.
- 4. In the above view of the matter and in absence of any objections either from the school management or from any parent, till this date, the committee hereby determines the final fees on the basis of provisional fees determined by the committee vide its order dated 29/05/2018.

5. The final fees for the academic year 2017-18 are as under :-

Terms and conditions:

- 1. The school is not permitted to collect fees for the first quarter of 2018-19, more than fees determined for the year 2017-18.
- 2. The school is permitted to charge fees for the academic year 2018-19 and 2019-20 by giving rise of 5% in the final fees determined by the committee for the year 2017-18.
- 3. It is further made clear that the school is not permitted to collect fees under any other head including under the head of Admission Fees or term fees and thereby causing extra burden on the students.





- 4. Any violation of this order shall be dealt with by the Committee in accordance with law, on being brought to the notice of the Committee by any aggrieved party.
- 5. If the school management has any grievance against the final fees determined by the committee, it shall have a right to file revision before the Fees Revision Committee within three weeks from the date of receipt of the order and after making payment of Rs.10,000/- by way of filing fees.
- 6. The school is directed to place the order determining final fees on its notice board as well as on its website.
